TERMS AND CONDITIONS OF REPAIR ORDER

We are not responsible for loss or damage of or to your vehicle or contents due to fire, theft, vandalism or similar perils. Used parts become the property of THE GEAR CENTRE unless customer otherwise directs. After 90 days, unclaimed parts will be sold by tender. Storage of \$5.00 per day is chargeable on vehicles and parts not claimed within 24 hours of completion of work. No claim or work order dispute will be honored beyond 30 days. Payment must be made without deduction and customer expressly waives anyright to setoff. Subject to taxation, all legal, locate, seizure and other costs will be added to amount owing.

END USE ACKNOWLEDGEMENT

Certain goods are imported under conditional duty relief for use in the repair of road tractors for semi-trailers, motor vehicles for the transport of ten or more persons (including the driver), ambulances and hearses, motor vehicles for the transport of goods, or fire fighting vehicles, and chassis therefore, or for use in the manufacture of repair parts thereof. THE GEAR CENTRE warrants to the original purchasers that its rebuilt power-steering pumps, gears, cylinders, attachments and other hydraulic components (herein after referred to 'units'), are reasonably free from defects in material and workmanship when properly installed and adjusted according to the original manufacturers recommendations and shall be limited to the replacement or repair of any part or parts of the units which may be proven defective under normal use and service within 12 months for on-highway vehicles and 3 months of on/off highway vehicles after installation of the units for the original purchaser, and which to THE GEAR CENTRE'S examination shall disclose to its satisfaction to be thus defective. In no event shall THE GEAR CENTRE be liable for consequential or special damages, or for transportation, downtime, installation, adjustment, or other expenses which may arise in connection with such unit or parts. In the event that any such unit or part proves to be defective in material or workmanship, the original purchaser waives his or its rights to consequential, special, or incidental damages, and such original purchasers exclusive remedy shall be the replacement or repair of such units or parts as deemed by THE GEAR CENTRE. This warranty is expressly in lieu of all other warranties expressed or implied including the warranty of merchantability and fitness for any particular use or purpose, capacity and all other obligations or liabilities on THE GEAR CENTRE'S part, and THE GEAR CENTRE neither assumes, nor authorizes any other person to assume for it, any other liability in connection with the sale of such units. This warranty shall not apply to any unit or any part thereof which has been subject to over-heating, improper installation, impact or accident damage, negligence, alteration, abuse, misuse, damage caused by failure of components other than that which THE GEAR CENTRE supplied, contamination, and including, but not limited to scored bearing and seal surfaces on shafts; warranty is void if unit not repaired to THE GEAR CENTRE'S specifications. THE GEAR CENTRE makes no warranty whatsoever in respect to accessories or parts not supplied by THE GEAR CENTRE. The term 'original purchaser' shall be deemed to mean that person, firm, or corporation for whom the unit was originally sold.
